

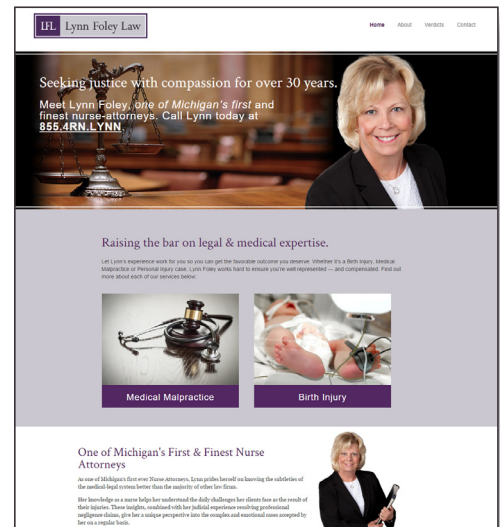
New Law Firm and Website Give Access to Highly Qualified Nurse-Attorney Lynn Foley
