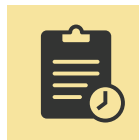

On the other hand, our SURROGATELITE Pregnancy Care was created specifically for you and for gestational surrogacy pregnancies – and the potential uncertainties that surrogacy brings with it.

With Sage, no lien is placed on the policy that requires you to pay up to \$25,000+ after the birth to defray the costs of a surrogacy pregnancy. You will also not have to worry if your plan will cover the pregnancy, as it was explicitly designed for surrogacy.

SURROGATELITE Pregnancy Care is for the pregnancy, not the calendar year. There is no worry about changes or losing coverage on January 1st of the next calendar year.
